1. 論文要旨 Thesis overview and summary of the presentation.

The thesis examines university-industry collaboration. Specifically, it investigates a) the influence of characteristics of universities and firms on collaborative modes and b) the influence of mode on outcome by using cases of Japan and Thailand as representatives of developed and developing countries respectively.

The salient findings are summarized as follows. In Japan and Thailand, university type and firm characteristic (firm size and industrial sector) influence collaboration mode. With regard to the collaboration mode, the university and industry collaboration in Japan is based on R&D activities and technology licensing whereas Thailand's university and industry collaboration is based on cooperative education and consultation. Consultation mode seems to be important for Thai case. More importantly, when consultation mode is used to complement to other modes such as R&D mode and cooperative education mode, it seems to relate to collaboration outcomes. Type of collaboration mode influences collaboration outcome. Different collaboration mode influences different outcome. Intellectual property is an important collaboration outcome for Japanese case whereas product and process innovation, and product and process improvement seem to be collaboration outcomes for Thai case.

Ms. Siriporn made a very clear presentation that lasted for about 1 hour and subsequently the referees made several questions and comments.

2. 審査報告 Notes from the Doctoral Thesis Review Committee (including changes required to the thesis by the referees)

The referees unanimously agreed that the student has passed and made the following comments:

- 1) Definition of different types of universities should include their missions and an explanation on their real activities is required.
- 2) On chapter 3, country context should be integrated into the framework.
- 3) Before the framework, a general explanation of university-industry relationship in developed and developing countries should be added.
- 4) An observation on the relevance of applying the Pavitt's taxonomy to developing-country context should be given.
- 5) When analysing activities of different types of universities, similarity

aspects between Thailand and Japan should be included, not only their differences.

- 6) Policy recommendations should differentiate between developed and developing countries.
- 7) Further studies should include hypothesis on expected relationship between university and industry in developed and developing countries.

The referees asked the main supervisor to check and approved the revised version of the thesis.
